## **ABOUT JADCO**

#### **Overview**

As part of the Government of Jamaica's commitment to the fight against doping in sport, on November 17, 2003, the Cabinet approved the adoption of the World Anti-Doping Programme and the World Anti-Doping Code. On February 10, 2004, Jamaica became the 97<sup>th</sup> Signatory State to the UNESCO Copenhagen Declaration on Anti-Doping in Sports. The Jamaica Anti-Doping Commission (JADCO) was established by the Anti-Doping in Sport Act, 2008.

The Government in its commitment to sport, will do everything in its power to safeguard the integrity, values and 'spirit of sport,' and to ensure an anti-doping environment which influences behaviour among participants, and dissuade athletes from using prohibited substances and prohibited methods. Sport is an integral part of Jamaican lifestyle and culture. Doping in sport is contrary to the spirit of sport. The fight against doping requires a comprehensive approach that involves education, prevention, international collaboration, detection, deterrence, rehabilitation, reintegration, and research by the government, sporting and medical communities.

#### Mission

Work towards fostering a doping-free environment in Jamaica that promotes the ethics and spirit of sports and deters the use of banned doping practices in sport through education, testing, advocacy and coordination of the Jamaica anti-doping programme.

#### Vision

To promote excellent performance through doping-free sports

#### **Objectives**

The main objectives of JADCO as outlined in the Anti-Doping in Sport Act, 2008, are to:


- 1. Educate athletes, support personnel, parents, media and the general public about drug use in sports.
- 2. Adopt and implement Anti-Doping in Sport Rules.
- 3. Implement the policies and programmes of the Government against doping in sport.
- 4. Direct the National Anti-Doping Programme specific to sport, which is inclusive of the collection of samples and the management of test results in keeping with the mandatory standards set out in the World Anti-Doping Code and International Standards.
- 5. Conduct and promote Anti-Doping research that contributes to the development and implementation of efficient programmes within doping and Anti-doping information and education.

### **ABOUT JADCO Cont'd**

- 6. Cooperate with the testing and education initiatives of the World Anti-Doping Agency (WADA), and other Anti-Doping Organisations and encouraging reciprocal testing with other national Anti-Doping Organisations.
- 7. Encourage and facilitate the negotiation by Sports Organisations and Anti-Doping Organisation of agreements and permitting their members to be tested by duly authorised Doping Control teams from other countries.
- 8. Advise the Minister on policies and practices related to doping in sport.

The Jamaica Anti-Doping Commission consists of five (5) divisions, namely Executive Office, Human Resource Management and Administration, Finance and Accounts, Technical Services and Communication and Education.

HRM and Administration manages the recruitment and selection of employees, the employee benefits programme and develops and coordinates the employee training and development strategies.

The Communication and Education Division plays an integral role in educating athletes, athlete support personnel and the public. JADCO creates and disseminates brochures and organises seminars, symposiums, anti-doping workshops and a variety of outreach activities.

The information shared enables our target audience to increase their knowledge of the role of JADCO, the Jamaica Anti-Doping Programme and the World Anti-Doping Agency (WADA), the doping control process and prohibited substances and methods.

The Technical Services Division is responsible for carrying out the doping control and results management aspects of the anti-doping programme including conducting testing of athletes, planning, coordinating and implementing the collection of samples and the management of test results in accordance with the mandatory International Standards set out in the World Anti-Doping Code.

### **CHAIRMAN'S STATEMENT**



The 2013/2014 financial year was a challenging one for the JADCO team. It was a period in which we embarked on a rigorous restructuring programme aimed at positioning the organisation to better fulfil its mission of fostering a dope free sporting environment in Jamaica.

The current board took office in January 2014, at the height of the restructuring period and I would like to congratulate JADCO's management and staff for remaining committed to the task and being resilient.

We continue to chart the way forward for the Commission with the help of our international and local partners. We have begun working with the Canadian Centre for Ethics in Sport (CCES) as well as the World Anti-Doping Agency (WADA) to develop strategies which will help improve our operations. During the period under review, 270 doping tests were conducted, a major improvement when compared to the last financial year. The workshops provided secondary school athletes and their support personnel with the opportunity to obtain information on anti-doping.

The JADCO team remains committed to working with all stakeholders in sport to ensure that the Jamaican Anti-Doping in Sport Programme is administered to the highest standard and that individuals are fully armed with information on anti-doping.

These achievements are only the beginning and we look forward to making additional accomplishments as we work towards developing a world-class anti-doping organisation that promotes excellent performance through dope free sport.



### **EXECUTIVE DIRECTOR'S STATEMENT**

Despite the challenges of the 2013/2014 financial year, the Commission has made significant strides in the ground work for a robust Anti-Doping programme. 
As we go forward, the Commission will continue to promote the ethics in sports by fostering a dope free environment in Jamaica.

### **ANNUAL REVIEW**

The year 2013-14 marked another significant year of progress for the Jamaica Anti-Doping Commission (JADCO). We were able to carry out 270 tests for the fiscal year. We implemented our inaugural **Junior Athletes Anti-Doping Education Workshops** in collaboration with the Jamaica Athletics Administrative Association (JAAA).

Since the formation of JADCO, the government of Jamaica felt it necessary for the organisation to partner with a high functionary National Anti-Doping Organisation (NADO). To this end, talks were entered into in an effort to build capacity with the CCES in December 2013 and a joint initiative proposal was signed in February 2014. This was done to develop a project plan that would ensure the JADCO's programme would meet the requirements of the 2015 Code and mandatory International Standards.

JADCO will continue to work assiduously to ensure that future generations of athletes are inspired to participate in all sport dope free. The guidance and commitment of our Commissioners and our dedicated staff have been fundamental to the organisation's growth over the years. They have created a platform for all the achievements reported during the period.

This Annual Report is intended to provide an update on JADCO's activities during the 2013-2014 financial year.

As we close another year, JADCO looks ahead to a bright and rewarding era in the fight against doping in sport.

The Communication and Education Division of JADCO continued in its commitment to develop and implement quality communication and education programmes for athletes and athlete support personnel across Jamaica.

In the Financial Year 2013 - 2014, the Division successfully delivered programmes driven through various communication channels and educational activities. The most utilised channel was face to face workshops with athletes and their support personnel.

#### Junior Athletes Anti-Doping Education Workshops

During the period February to March 2014, JADCO in collaboration with the Jamaica Athletics Administrative Association (JAAA), hosted the inaugural *Junior Athletes Anti-Doping Education Workshops* in five regions across the island for secondary school athletes and their support personnel.

The workshop included presentations from representatives of JADCO, JAAA and Medical Practitioners. As a result of the workshops, participants were able to increase their knowledge of the role of JADCO, the World Anti-Doping Agency (WADA) and the Jamaica Anti-Doping Programme. They were also informed about the Doping Control Process, banned substances and the role of support staff.

#### World Anti-Doping Agency Prohibited List

The World Anti-Doping Agency (WADA) Prohibited List comes into effect on January 1 each year. In January 2014, the Commission printed a total of 3000 Prohibited Lists to be distributed to all Associations, Federations, athletes and their support personnel at anti-doping workshops.

### **Communication Activities**

The Communication and Education Division improved its public awareness strategy during 2013-2014, as it increased the number of press releases disseminated to the media. The press releases were utilised when necessary to make JADCO's presence more visible both locally and internationally. The Division also increased the number of the photo captions disseminated to the print media. JADCO also continued to utilise social media such as Facebook, YouTube and Twitter to disseminate crucial messages to our target audience.

or the fiscal year 2013-2014, the Commission planned on conducting a total of 335 tests, 175 In Competition and 160 Out-Of-Competition. However, only 270 urine tests were done; 152 In Competition and 118 Out-Of-Competition (*See table below*).

#### **CCES AND WADA VISIT**

The World Anti-Doping Agency (WADA) visited the island from October 28-29, 2013. Following their visit, the Executive Director was invited to visit their Headquarters in Montreal, Canada from December 18-19, 2013 for an orientation. During this time, he visited the INRS Laboratory to tour the facility and to observe operations and gain a greater understanding of the protocol involved in dealing with samples sent to the lab, particularly in the case of an Adverse Analytical Finding. He also visited the Canadian Centre for Ethics in Sport (CCES) to explore the possibility of forging a partnership between the CCES and JADCO in order to build capacity at JADCO and to discuss the operational aspects of the Canadian Anti-Doping Programme.

Auditor General's Report To the Accounting Officer of the Office of the Prime Minister

#### **Report on the Appropriation Account**

I have audited the accompanying Appropriation Account of the Office of the Prime Minister – Head 1500 which comprise the Account by Objects, Activity/Projects and explanatory statement of the causes for variation between approved estimates and expenditure as at March 31, 2014.

#### Accounting Officer's Responsibility for the Account

The Accounting Officer is responsible for the preparation and presentation of the Account in accordance with the Financial Administration and Audit Act. This responsibility includes: designing, implementing and maintaining internal controls relevant to the preparation and presentation of the Appropriation Account that is free from misstatement, whether due to fraud or error; applying the requisite government accounting policies; and ensuring that transactions and events are executed in accordance with laws and regulations that are appropriate in the circumstances.

#### Auditor's Responsibility

My responsibility is to express an opinion on the Account based on my audit. I conducted my audit in accordance with the Financial Administration and Audit Act and the auditing standards issued by the International Organization of Supreme Audit Institutions (INTOSAI). Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Appropriation Account is free from misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Account. The procedures selected depend on the auditor's judgment, including the assessment of the risks of misstatement in the Appropriation Account, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Ministry/Department's preparation and presentation of the Appropriation Account in order to design audit procedures that are appropriate in the circumstances. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of the explanations provided by management, as well as evaluating the overall presentation of the Appropriation Account.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

#### Opinion

In my opinion, the attached Appropriation Account is a fair representation of the financial transactions for the year ended March 31, 2014 in accordance with Section 24 I (1) (a)(b) of the Financial Administration and Audit Act.
